Late Tuition Payments:

I understand and agree that payment of the balance of the tuition and fees are due on, and are to be paid no later than, the due date(s) as set forth above and that a penalty of \$35.00 may be charged at the option of Precept Schools of Virginia (PSV) if any payment is received more than 5 (five) calendar days after its due date without prior approval of the Head of School.

Agreement with Rules and Regulations:

I understand that in signing this Enrollment Contract for this academic year I am agreeing to accept and abide by the rules and regulations of PSV.

I understand I can expect my child to receive the classical form of the grade level education previously indicated. In return for this, I also understand that I am obligated to pay in full the tuition amount referenced above along with other mutually acceptable and necessary fees to further my child’s education such as book fees, uniform fees and other. I further understand that no portion of the tuition and fees paid or outstanding will be refunded or canceled in the event of absence, withdrawal or dismissal of the registered student from the school unless mutually agreed upon by all signing parties and approved by the PSV board.

My signature below evidences my agreement to abide by and be bound by the policies of PSV as established by the PSV board. No grades, transcripts or results of standardized testing will be released until all fees are current. If delinquent payments are outstanding, appropriate legal action may be necessary.

I further agree that the school reserves the right to dismiss (expel) any student at any time for academic or disciplinary reasons or for non-payment of fees or for parental non-compliance if such dismissal is determined to be in the best interest of the school.

Authorization for Mediation:

In the event that I break this contract by ceasing to pay tuition, I hereby authorize PSV to contact the pastor and /or the governing body of the paying parent’s church, for the purpose of seeking mediation.

Choice of Law:

This contract is legally binding and shall be interpreted in accordance with the laws of the Commonwealth of Virginia.
